**Subject:** Re: Right Of Way Trees

Hi Ron,

Thank you for the feedback on Chris' crew, I'm proud of the excellent job they've been doing.

You've requested us to top trees. As I mentioned, we're diligently working through a substantial backlog of work, for example filling the potholes on 67th PI yesterday, all of which is a higher priority to the County. I would only prioritize tree topping or removal where the tree is dead or damaged (eg lightning struck), and that tree presents a danger to the public by potentially falling either on a road, path, or structure. If you have any trees fitting that description, please do pass them on to me.

For trees that you would like to top or remove from the ROW for aesthetic reasons, Pacific County does not currently have any permitting required for this work. If you remove a number of trees or the root wad of a large tree, please seed the area to stabilize it, and monitor it for erosion until the seed is established. I would recommend getting concurrence from the nearby property owners. If you have any equipment in the traveled way (road, path, shoulder) for this work, please use one of WSDOT Standard Traffic Control Plans for either Shoulder Closure or Lane Closure. I would prefer the equipment stays off of the traveled way where possible, for safety reasons for both your operator and traveling public.
