



Driving Directions: from I Street turn east on 320th, north on J Place, east on 322nd, north on K Place, east on 324th to the end of the road (2021 324th Place).


Despite repeated reminders some folks are still putting trash other than what is allowed in the compactor. This bag of clothes caused it to be emptied half full.

Shoreline Management Act Rulemaking: Sea level rise webinar series

Ecology is currently conducting rulemaking under the Shoreline Management Act. A major focus of this rulemaking is to establish a new requirement for cities and counties to address the impact of sea level rise and increased storm severity in their shoreline master programs. As Ecology begins to draft these new requirements, we will be considering sea level rise science, anticipated impacts, available models and tools, management issues, and examples of adaptation planning.

We are organizing a webinar series to host scientists and practitioners to present on these topics. These webinars are open to the public – we invite you to join us at lunch time in February and March for these presentations.

The objectives of the webinar series are to:

- 1. Provide the public with an opportunity to learn about sea level rise from experts.
- Engage experts to ensure the agency considers the best available science and adaptation planning best practices as we develop the new rules.
- Provide transparency around the information the agency intends to consider as we develop the new rules.



ARCHITECTURAL COMMITTEE

Plan on installing a fence, a shed, a gazebo or building a garage or a house? REMINDER...

ALL building plans must be submitted to the Architectural Committee <u>prior</u> to any construction.

Pacific County will not approve permitting until the committee has signed off on all plans.

The committee meets every Tuesdays at 9 a.m. at the business office. The plans MUST be submitted by Friday at noon to be added to the next week's agenda. The building packets are on our website at <u>surfsideonline.org/forms/</u> or you can pick them up from the business office.

Please notify the business office if you want to attend the meeting in person.

If you are building on a vacant lot without an address, please post a sign so the committee knows which lot will be developed.

Two (2) sets of plot plans must be submitted to the committee. Once approved, you will get a copy of the approved plan. Take it to the county for their approval as needed. Surfside will retain one set of approved plans to keep on file.
